Know to all men these presents,

This Deeds of Absolute Abolition of Powers, Rights and Authorities to be a Sole Signatory for being a Sole Redeemer, Holder and Intermediary of the Mother and Extended Accounts was hereby made and executed by and between Pres. Ferdinand E. Marcos which referred to as First Party and Foreign Counterparts which referred as Second to Fourth Party dated December 21, 1988 at the Buckingham Palace, London, England against the following:

WITNESSETH







All Foreign and Philippine Government who hold the title of the Republic of the Philippines including commercial and private banks, both locally and globally, in any forms of judicial summary, summon, resolutions, decision and other legal means that exhausting, cancelling and terminating the 70% authority of the People of the Philippine Islands to all their Assets and Properties and thru all means, the Republic of the Philippines are Disallowed and Unauthorized to use any 10, 000, 000 Signatory of the Filipino People without the Proper Endorsement of Anthony Santiago Martin for Claiming Mother and Extensive Accounts of the First Party.


This Deed of Absolute Abolition was been executed against above referred names and other unmentioned names who hold Money Claim Papers and other documentary means with Left-handed Signatory of the First Party in order to Halt, Disappoint, Reject, Refuse, Expunge, Terminate, Exhaust, Cease, Desist and Cancel, at all cost and effect, any Monetary Rights, Power and Authority to be a Sole Signatory for being a Sole Redeemer, Holder and Intermediary of the Mother and Extended Accounts as said Rights of the First Party was irrevocably and unopposed to Cede, Assign, Entrust, Appoint and Transfer with solely full and absolute rights, power and authorities to sign for redemption, hold and mediate the Maturity of the Mother and Extended Accounts that 70% intended for the benefit of the People of the Philippine Islands to Anthony Santiago Martin or Spiritual Wonder Boy or AM - 01 or Spiritual King David of Israel, who hold this instrument and other instrument that formally recorded in the United Nation Mission Office in the Philippine Islands and to his legitimate wife, Lyn Grace H. Medina - Martin or Spiritual Maria Cristina or C1 - C2 or Spiritual Queen Bathsheba who must be required to be purely and wholeheartedly married to his husband Anthony Santiago Martin as their Legal and Spiritual Matrimony was been set by the Holy Father in Heaven and no further opposition from all parties concerns are raised from this date and beyond and only papers of the First Party with Right Handed Signatory are duly Recognized.

In witness and faith whereof, we hereunto signed this Form without any witness this December 21, 1988 at the Buckingham Palace, London, Great Britain.



